

TOURNAMENT INFORMATION

Rules and Regulations

Rules of the USTA shall govern play. Players are required to have a current USTA membership. Memberships may be obtained at www.USTA.com or at the tournament desk.

Each player is limited to two events.

Players should be available to play starting Friday morning, January 13, if needed.

Events must have a minimum of 4 entries. Men's Open Singles is limited to 64 entries; Men's Open doubles is limited to 32 entries. All other draw sizes may be limited at the discretion of the tournament committee.

All matches will be best of three sets; at six games all, the twelve point tiebreaker will be in effect. "No-ad" scoring may be used until the semi-finals.

Match times and directions will be available starting Tuesday, January 10 by 6:00pm at www.pnw.usta.com at the TennisLink site.

Players may be defaulted if not checked in 15 minutes after scheduled match time. Warm-up is limited to 5 minutes.

The tournament committee reserves the right to reject any entry or refuse admission to any player who fails to cooperate with the tournament committee. The point penalty system, wherein a player is penalized in his/her matches for infractions (racquet throwing, swearing, etc.) will be used.

Prize money will be awarded to finalists in Men's and Women's Open Divisions.

Entry fees must accompany entry blank or name will not be placed in the draw. **Entries can be submitted on the USTA TennisLink web site using tournament # 600100312.**

Fees are **\$25** for singles and **\$30** per team for doubles. Fees must accompany entry blank to be placed in the draw. No refunds once draws are made.

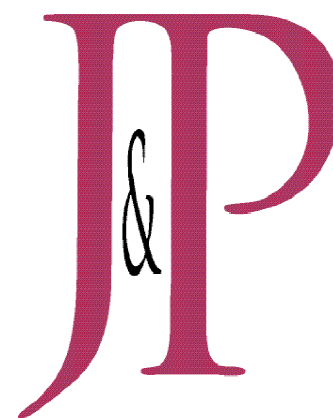
